#### O President's Report

#### **Unfinished Business**

Unfinished Business: 1. Last meeting we discussed a FAST CAT event. Barbara Parker checked with her all breed club and they already brought in another club. Beth Peterson was investigating with AKC in regards to territory and other matters. Beth was not present to give an update. Below is an updated email from Beth:

As a Regional Club - we have NO limits to the location of where we host a Fast CAT trial. We may host two runs per day, up to 6-days (12 runs) per year.

We must complete an AKC Event Application within 3months of the Fast CAT event. (Attached)

We may hold up to two Fast CAT events each day - and each event must be applied for individually.

Fees must be included with each application.

Licensed Fast CAT clubs may hold up to 12 events per year.

Fast CAT events must be at least 100 miles from any other Fast CAT event.

Mileage Conflict: If there is a mileage conflict, the second club may hold the Fast CAT events only if, in each instance, it obtains the written permission of the club with the established date. This written permission (one per event) must be sent along with its event application.

*Clubs must have an Event Committee (3+ persons) for each event.* 

*Mr.* Yu Ching-Yau (he prefers to be addressed as Ching) is one of the most used superintendents in the mid-Atlantic region. His direct email: Ching@cyu.com

Mary Novocin has asked Beth to contact Ching and see if our club can host this event sometime this summer.

#### ○ | New Business

Independent vs. all breed. KC of Anne Arundel is offering \$4/dog, reserve grooming, rosettes and in the new section of the Howard County building and we can submit names for our preferred judge. Most preferred the May date. July will be out now as an independent as Gulf Coast Tibetan Spaniel Club will be moving to the date we had picked. Finding any days without dog shows already within the mileage is difficult. Richard Jackson informed Mary Novocin that the Mid Atlantic Non-Sporting Club will be moving to Doswell. Based on the board meeting it looks like we are leaning towards doing an independent show about every 3 or 4 years and the rest will be designated or concurrent with an all-breed club. Motion was made by Harold Hartman and seconded by Mary Hartman to join KC of Anne Arundel and stick with the May date. All were in favor, one abstained. Motion carried.

We had some discussion on the Breeder Seminar for the National this year. Linda Foiles has some packets made and would like to some dogs available for hands on so breeders to see what to look for. She will need samples of different types and dogs that are not actively being shown. She will also want to explain more about in line breeding and out cross breeding.
